1. ORGANIZER is committed:

- 1.1. To organize the exhibition "Ką pasėsi... 2021" on September 23-25, 2021.
- 1.2. To pursue obligations, provided in this agreement, exhibition rules and Participant application.
- 1.3. To organize the advertising campaign of the exhibition in mass media and in internet. To distribute advertisements and invitations to the exhibition, to publish exhibition catalogue and include the information about the Participant in it.
- 1.4. After Participant arrives and checks-in in information center, provide the Participant with 3 identification cards of the exhibition Participant and permit to park.
- 1.5. To organize educational program during the exhibition.
- 1.6. To award the best exhibits with "Ką pasėsi... 2021" medals.
- 1.7. To compact a civil responsibility contract with insurance company for the damage accidentally caused to Participants, visitors or third party during the exhibition. Exhibitors insure exhibits.
- 1.8. To organize public order protection.
- 1.9. To organize protection of expositions from 5 p.m. till 9 a.m. on exhibition days.

2. PARTICIPANT is committed:

- 2.1. To participate in the exhibition "Ka pasesi... 2021" on September 23-25, 2021.
- 2.2. To pursue obligations, provided in this agreement, exhibition rules and Participant application form.
- 2.3. Before July 9, 2021 register to participate in the exhibition online at www.expoacademia.lt (fill application and information for catalogue there). After registering after the specified date, the Organizer does not undertake to publish information about the Participant in the exhibition publications. Send the signed Participation Agreement to the Organizer by e-mail mtp.zua@vdu.lt.
- 2.4. To remit money for the occupied space, requisites and services following the advance invoice within 10 working days, but not later than 3 days before the exhibition start. Indicate in payment orders: for the exhibition "Ką pasėsi... 2021". The otherwise application is canceled. Original invoice will be delivered during exhibition.
- 2.5. To allocate sub exponent (other company) in the participants stand just in case it has been indicated in the application form and fee for the sub exponent has been paid.
- 2.6. To mount the exposition stand in the place (territory) indicated by the Organizer within the indicated time September 20-22, from 9 a.m. till 5 p.m.
- 2.7. Observe the rules on occupational safety and health and fire safety.
- 2.8. Before mounting exposition, check-in in information center (pavilion No.2) and take participant badges, permissions to park there.
- 2.9. To look after the exhibits during the exhibition working hours. After working hours security service takes care.
- 2.10. Last day of exhibition stay in exposition stand till 5 p.m.
- 2.11. To take the exhibits back only after the exhibition is over, i.e. on September 25 from 5 p.m. to 8 p.m., September 27, from 8 a.m. to 1 p.m.

3. OTHER AGREEMENT TERMS

- 3.1. The Participant application and the exhibition rules are integral parts of this Agreement (not included separately).
- 3.2. In case of refuse to participate in the exhibition, registration fee is not returned. If refused more than 20 days before the exhibition, 50 percent of prepayment is returned. Later than 20 days to exhibition prepayment not returned. Applications arrived after deadline accepted at organizers discretion.
- 3.3. Upon the announcement of quarantine in the territory of the Republic of Lithuania or adoption of legal acts by the authorities of the Republic of Lithuania prohibiting or restricting the organization of events or otherwise substantially affecting the performance of this agreement or making its implementation impossible due to reasons related to COVID-19, the Organizer has the right to cancel the exhibition "Ką pasėsi... 2021" and unilaterally terminate this agreement. In this case, upon the written request of the Participant, the

Organizer undertakes to return the fee paid by the Participant for the exhibition area, equipment, and additional services, except for the registration fee.

- 3.4. In case the exhibition cannot be held on the date provided for in clause 1 of this Agreement due to the legal acts of the Republic of Lithuania prohibiting, restricting or otherwise influencing the organization of this exhibition, the Organizer reserves the right to change the date of the exhibition. If the Exhibitor refuses to participate in the Exhibition at the changed time, the fees paid by him shall be refunded in accordance with the procedure laid down clause 3.2. of this Agreement.
- 3.5. The agreement is valid by the countersign participation agreement and taking all responsibility satisfaction.
- 3.6. Conflicts between the parties of the agreement solved based on mutual consent and following laws of the Republic of Lithuania. Judicial determination is based on the location of the Organizer's seat.
